

ACT INDEXATION BENEFIT GUIDE

The *Workers Compensation Act 1951* (WC Act) allows for indexation of benefits such as adjustment of wages to weekly compensation, permanent impairment, death, medical treatment, damages and other costs, according to changes in the cost of living or another economic indicator, especially to compensate for inflation.

Weekly compensation, for a worker means the worker's average pre-incapacity weekly earnings less the average weekly amount that a worker is being paid for working or could earn in reasonably available employment. Entitlements to weekly compensation are likely to change after 26 weeks whether the worker is totally incapacitated or partially incapacitated.

SCHEDULE 1 COMPENSATION FOR PERMANENT INJURIES

If a worker who has suffered a loss mentioned in an item of [schedule 1](#) (Compensation for permanent injuries) of the WC Act as the result of a compensable injury, the worker is entitled to receive from the worker's employer, as compensation for the loss, the percentage of the single loss amount mentioned in that item. If a worker who has suffered 2 or more losses mentioned in [schedule 1](#) because of an injury is not entitled to receive as compensation under this part more than the maximum loss amount for the losses. (see s48 and s51)

4.5 COMPENSATION FOR MEDICAL TREATMENT, DAMAGE AND OTHER COSTS

The Workers Compensation Act 1951 may require an employer to pay compensation for medical treatment, including rehabilitation services, some alterations, accommodation (including the cost of meals) and transport costs in relation to a workers' compensation claim. The indexed benefits for these amounts are listed in the following tables.

4.6 COMPENSATION FOR DEATH

If there is a work-related death, dependants are entitled to the benefits compensation for death.

dependant, of a dead worker, means an individual—

- (a) who was totally or partly dependent on the worker's earnings on the day of the worker's death or who would, apart from the worker's incapacity because of the injury, have been so dependent; and
- (b) who was—
 - (i) a member of the worker's family; or
 - (ii) a person to whom the worker acted in place of a parent or who acted in place of a parent for the worker.
